## SUBCONTRACTOR CONFLICTS

- SNAP-UP DOCTRINE: LEGALS OF UNDERQUOTING BY MISTAKE
- FINANCIAL INDISCIPLINE OF SUBCONTRACTOR
- BLAME GAMES BETWEEN SUB-CONTRACTORS AND CONSULTANTS
- IF CONTRACTOR ABANDONS JOB, REPLACEMENT CONTRACTS ARE
  ALWAYS COSTLIER



IF SUBCONTRACTOR IS NOT REPUTED FIRM, MICRO-MANAGE THAT FIRM

CONDUCT ALL-PARTY PROGRESS REVIEWS, RECORD MINUTES

PREFER ITEM-RATE, IF SUBCONTRACT CREDENTIALS ARE DOUBTFUL

# CIVIL LABOUR & LABOUR SUBCONTRACT

- LUMPSUM SUBCONTRACT RATES IS JUST GUESSWORK
- EXCAVATION, PLASTERING, SHUTTERING GAINS MONEY, MASONRY AND CONCRETE LOSES MONEY
- LIKELIHOOD OF EXCESS WEEKLY PAYMENTS



MICRO-MANAGEMENT OF LABOUR CONTRACTOR – PROVIDE HELP DEVELOP LONG TERM RELATIONSHIPS WITH LABOUR CONTRACTORS MAKE ESTIMATE OF ITEM-WISE LABOUR RATES EVEN ON FIXED CONTRACT

## LABOUR COST ESCALATION

- BASED ON A STUDY BY SATHYABHAMA ENGINEERING COLLEGE (2014) AND ON-GOING STUDY BY ADEPT ALGORITHMS
- ESCALATION OF LABOUR COST PER ANNUM: AVERAGE 10%; MAX 12%
- MATERIAL COST IS INCREASING AROUND 4-5% PER ANNUM
- OVERALL CONSTRUCTION COST INCREASES APPROX 10% PA
- MARGIN IS CONSTANTLY REDUCING



TIME TO MOVE TOWARDS LESS LABOUR INTENSIVE CONSTRUCTION: E.G. – PRECAST PANELS INSTEAD OF CONVENTIONAL PLASTERED BLOCKWORK

USE MORE MACHINERY, BUT REDUCE PLANT AND OVERHEADS
